Dr. Imbasciani gave a presentation which will be summarized by DOD staff in a separate report.

ITEM NO. (6): UPDATE ON CREATION OF A CITY HEALTH COMMISSION. Presentation by Tony Abraham, DOD.

Mr. Abraham reported that council file 14-0596 had created a health commission by a vote of 15-0 in city council, permitting each council office to nominate one appointee to the

commission. The commission is to work with the county's Department of Public Health to ensure that service is being delivered to residents of the city of Los Angeles. The new commission will develop a strategic plan to examine whether the city is being served adequately by the county's department, create a timeline for the strategic plan, and then report back to the City.

ITEM NO. (7): PREPARATION OF LETTER OF CONCERN ABOUT CUTS TO IN HOME SUPPORTIVE SERVICES. Presentation by Tony Abraham, DOD.

DISPOSITION: ACTION TAKEN

Mr. Abraham reported that Governor Brown conceded to authorize overtime pay for those providing in home supportive services, therefore no action required on this action.

However, the commission recommended further research on the status of the California Minimum Wage Supplement for Home Health Workers (2014) which would mandate 75 hours of training for all people provided IHSS services.
