### ITEM NO. (1): CALL TO ORDER, ROLL CALL, ANNOUNCEMENTS AND INTRODUCTIONS

Public comment granted. Sandra Clayton announced that an inter-faith meetings on mental health are held at 550 Vermont on September 11<sup>th</sup> at 10:00 a.m. Daniel Garcia and Genevieve Clavreul talked separately about accessible sidewalks, and the City's ADA Compliance Officer, Angela Kaufman, requested the location of those sidewalks be e-mailed to her.

# ITEM NO. (4): UPDATED ON PROPOSITION 41 AND ITS IMPLEMENTATION THROUGH THE VETERANS HOUSING AND HOMELESS PREVENTION (VHHP) PROGRAM.

### DISPOSITION: NO ACTION TAKEN. INFORMATIONAL PURPOSES ONLY\*

Carey Stone provided background information on the VHHP, indicating that the Department on Disability provided a letter about the use of available funds to the State of California, Department of Housing and Community Development (DHCD)

DHCD may dedicated a minimum of \$15 million to Los Angeles, but the money is available to developers to compete for through notice of funding availability to fund 500 units of veterans housing over two years.

United Way and the Corporation for Supportive Housing are coordinating funds reserved for supportive housing units for the Los Angeles area. They are working on developing a system for coordinating services for people who need housing, therefore they are looking for funds to hire coordinators that will operate what is being called the Coordinated Entry System (CES). The CES is an attempt to have coordinators issue to veterans and their families seeking of housing a questionnaire called Spedat to determine the consequences for the seekers if they don't

receive housing, and other social services. The CES will be used to ensure that supportive housing services are identified and provided to veterans and their families.

Currently, it is estimated that \$4,000 per year per unit can be used for the service coordinators.

# ITEM NO. (5): CONSIDERATION OF MOTIONS ASSOCIATED WITH VETERANS HOMELESSNESS AND PROPOSITION 41.

MOTION 08062014-5B relative to the Commission adopting the position that the Commission is committed to (1) housing, (2) medical care through improving access of veterans to specialized non-veteran health care facilities, (3) employment to develop educational program for employers to understand limitations of disabled veterans; and (4) government agencies to increase the coordination and communication between Department of Defense and Department of Veterans of Affairs.
