Item One (1) - Request for Remote Participation Option Pursuant to Government Code Section 54953(e)(2)(a)

Action Taken: There were no Commission members attending the Commission on Disability meeting remotely. No action required by the Commission on Disability.

Item Two (2) - Multiple Agenda Item Public Comment

Public comment was provided on the following topics applicable to the Commission's scope of work:

- Public Comment was made by various parties regarding Scientology:
 - Their negative philosophy about persons living with disabilities.
 - Inaccessible public parking even with placards at the Scientology Center on L. Ron Hubbard Way.
 - Public right of way barriers.
 - The permits issued to this organization.
 - Damage caused by the organization through unfair labor practices.

- Public comment was made regarding the Commission's new public comment procedure, specifically the preference that public comment be allowed after each item. Also mentioned was displeasure with the Board of Public Works' public comment procedure.
- Public comment was made about the City of Los Angeles' budget, fraud, and lack of transparency.
- Public comment was made regarding the Metro system and the elevators, specifically their need to be operable at all times.

Commissioner Bitonte inquired if discussion on the new public comment procedure could be had, with council advising that a discussion with the DOD GM or AGM be had for further information on the new policy.

No action taken, information purposes only.

Item Three (3) - Approval of the Regular Meeting Minutes

Executive Director Simon noted that a new, streamlined version of the minutes will be implemented for the August minutes for approval at the September meeting.

The Commission reviewed the July 2025 regular meeting minutes.

Action Taken: Commissioner Hopkins moved, and Commissioner Williams seconded, the motion to approve the minutes of the July 2025 regular meeting as amended. The motion passed.

Item Four (4) - Review and Approval of the Commission on Disability FY 2024-2025 Report of Accomplishments

The Commission reviewed the Commission on Disability FY 2024-2025 Report of Accomplishments.

Action Taken: Commissioner Williams moved and Commissioner Bitonte seconded the motion to approve

the Commission on Disability FY 2024-2025 Report of Accomplishments. The motion passed.

Item Five (5) - Presentation by the Department on Disability (DOD) about its Divisions, Services, and Annual Work Plan

Department on Disability staff presented on the Department's mission, services, staffing, Fiscal Year 2024-2025 accomplishments, and Fiscal Year 2025-2026 Work Plan. Questions and comments from the Commissioners followed.

Commissioner Bitonte asked how many applications for CORE were completed by the department and how many were not completed because of insufficient resources.

Lourdes Sinibaldi responded that denials are strictly under the purview of the Department of Water and Power and provided an overview of the process between DWP, DOA, and DOD. She spotlighted that the denial decision is not under the control of the DOD and offered to provide further data on the process and possible reasons for denials. She also highlighted some alternative approaches by other service providers.

Commissioner Bitonte noted the need and use of well tracked metrics.

Executive Director Stephen David Simon spoke to the increased metric tracking and the soon to be available greater data.

- Noted the changes in the DOD staff supporting the Commission and within the DOD.
- Noted the Olympics and Paralympics for the City of Los Angeles will be treated with equal importance and recognition.

City of Los Angeles Commission on Disability

Fiscal Year 2025-2026 Work Plan DRAFT

The Commission on Disability provides a forum for the identification and discussion of difficulties encountered by Disabled persons in our society, and makes recommendations to the Mayor and the City Council on measures which the Federal, State, and local governments may undertake to assure that persons with disabilities may participate without hindrance in the life of our community.

Powers and Duties

- 1. Advise the Mayor, the City Council and the Department on Disability on the needs and challenges of persons with disabilities in the City of Los Angeles.
- 2. Hold public hearings at least once a year as a regular or special meeting to take testimony from persons with disabilities and others regarding issues impacting the lives of persons with disabilities in the City of Los Angeles, and report the Commission's findings and recommendations to the Mayor and the City Council.

- 3. Monitor the program mandates of the Department on Disability and make recommendations to the Mayor and the City Council on program and policy initiatives to improve the service of the Department to the Disability community and provide persons with disabilities in the City of Los Angeles a better opportunity and ability to pursue activities of daily living without discrimination.
- 4. Review and make recommendations to the Mayor and City Council on funding disability access for City programs and services.
- 5. Maintain active liaisons with Disability community stakeholders interested in the problems facing persons with disabilities.
- 6. Promote greater awareness of Disability culture, as well as civic and community engagement of persons with disabilities.
- 7. Investigate and report to the Mayor and the City Council instances of discrimination based on disability, as well as ableism and attitudinal barriers in areas including housing, transportation, employment, recreation, public information, health and social services, civil and human rights, and legislation.

- 8. Perform specific studies and surveys on the needs of persons with disabilities when requested by the Mayor and/or the City Council.
- 9. Submit an annual report to the Mayor and the City Council on the activities of the Commission.

Existing Conditions for Passengers with Disabilities

Departing passengers with disabilities can be dropped off from their chosen form of ground transportation at ADA loading zones or dedicated drop off points (such as for hotel shuttles, etc.). When traffic in the Central Terminal Area (or CTA), the name for our roadway loop, is heavy, there can be lengthy delays to be dropped off at the curb. Once at the curb, under the Air Carrier Access Act, airlines are obligated to provide assistance for anyone with a disability if they request it, beginning at the curb if needed. Additionally, currently LAX does not have the necessary number of ADA loading zones but capital improvement projects are addressing the necessary corrective actions.





Existing Conditions for Passengers with Disabilities

The same circumstances can apply to arriving passengers who could wait extended periods for ground transportation to pick them up. Additionally, the limitations on access for rideshare services require most passengers to take the LAX-It shuttle to the rideshare lot, adding time to the arrival process. Passengers with disabilities do have the option to instead be picked up by an accessible taxi in front the terminals, or by Access Paratransit, but these services can also be delayed by heavy traffic.





FAA Office of Civil Rights On-site Mini-Compliance Review

In January 2024, the FAA Office of Civil Rights (OCR) sent the required notification letter to LAWA advising that an On-Site Mini-Compliance Review related to ADA would be scheduled.

Prior to conducting the on-site review, documents were requested and required to be submitted by February 19, 2024. Approximately 1000 pages of documents were submitted.

The original dates for the two-day review were March 12 and 13, 2024, but were rescheduled to August 27 and 28, 2024. Day one was attended by a number of LAWA staff, management and executives. City of Los Angeles Department on Disability facilitated an information exchange with Salt Lake City Airport (SLC) regarding their FAA compliance review, which proved invaluable. The FAA intends to review all large hub airports to ensure accessibility obligations are being met under Section 504 and Title 2 of the ADA.





FAA Office of Civil Rights On-site Mini-Compliance Review

During the on-site review, the FAA identified a number of areas requiring corrective action, such as curbside passenger loading zones and oversight of ground transportation providers and also included the obligatory self-evaluation due every three years. The programs and services related to the APM were reviewed as part of the self-evaluation process.



Proposed Conditions for Passengers with Disabilities

Once the APM goes live, departing passengers with disabilities can continue to be dropped off in the CTA by personal vehicles and Access Paratransit transportation, or at ITF East and take the APM to their terminal. If they are using a shuttle service, buses or rideshare, they will be dropped off at ITF West and then board the APM. If they park at the Economy Lot, they can board the APM at the ConRAC station.

The same circumstances will apply to arriving passengers. They can opt to be picked up by a personal vehicle or Access Paratransit on the lower level, or take the APM to the ConRAC station for a rental car or the Economy Lot, or ITF East or West depending on the ground transportation service they prefer.

This process is meant to significantly improve the passenger experience getting to and from the terminals.





Proposed Conditions for Passengers with Disabilities

The LAWA Self-Evaluation as well as multiple meetings between Capital Improvement Project (CIP) teams and the ADA Office have ensured the facilities and infrastructure are fully accessible. This includes the stations for the auxiliary curbs, the ConRAC station and any path of travel. A pet relief area is provided at ITF East. Additional and new pet relief areas are being included as part of the design process for the remodel of the lower traffic loop adjacent to parking structures.

Emergency blue phones present at the ConRAC were evaluated by the LAWA ADA Coordinator and a contracted CASp. Many phones are now fully accessible, but others are undergoing corrective actions to ensure alternative means of communication and clearances are satisfied.

Additionally, identifying responsible parties and finalizing procedures to support persons with disabilities during an evacuation has been at the forefront during operational readiness meetings.





Proposed Conditions for Passengers with Disabilities

Questions regarding ensuring accessible programs and services to support passengers with disabilities as they look to board the APM from the auxiliary curbs have been a priority topic brought to executive management for more than a year.

Support for passengers with disabilities by airlines under the Air Carrier Access Act will continue at the terminal platforms.

Additional services, such as wayfinding apps, will be made available and promoted to support independence for those with disabilities as well as providing or directing support resources when requested.
